

## General Description

The AOZ8S303BLS-11 is a single channel transient voltage suppressor designed to protect high speed data lines and voltage sensitive electronics from high transient conditions and ESD.

The AOZ8S303BLS-11 comes in an RoHS compliant package and is rated over a -40°C to +125°C ambient temperature range.

The ultra-small 0.6 mm x 0.3 mm 0201 footprint package makes the AOZ8S303BLS-11 ideal for applications where PCB space is a premium. The small size and high ESD protection makes it ideal for protecting voltage sensitive electronics from high transient conditions and ESD.

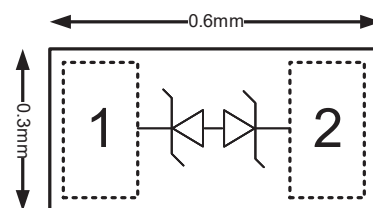

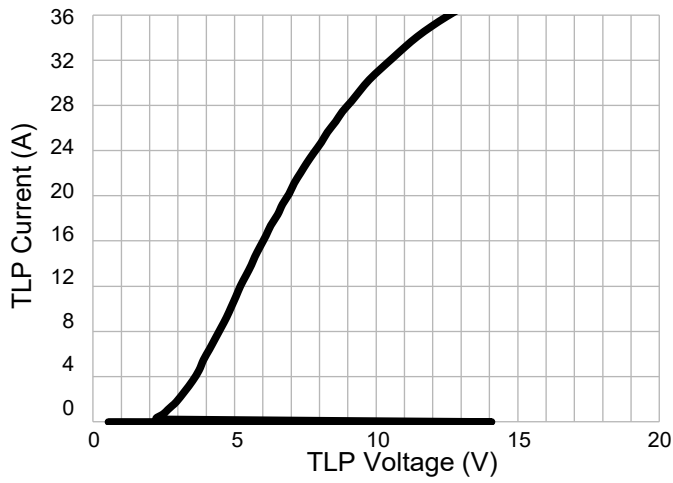

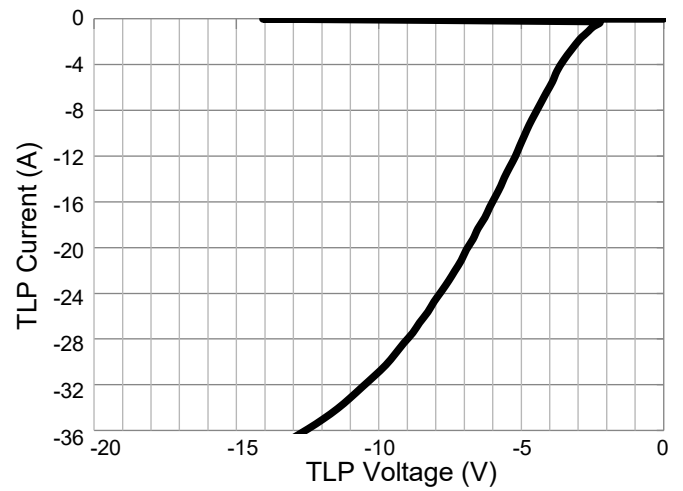

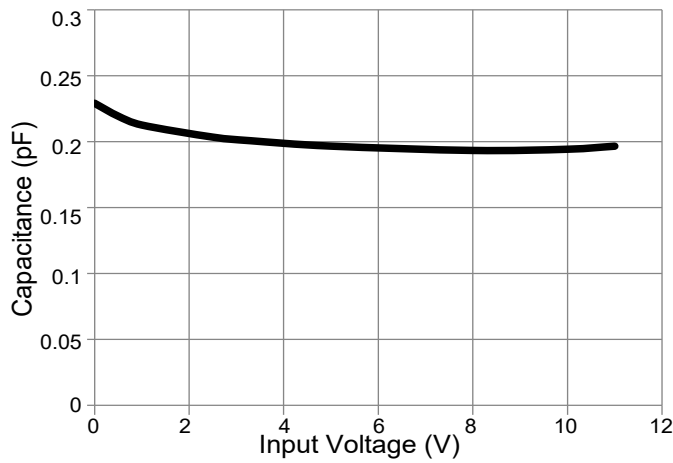
Positive Transmission Line Pulse  
( $t_p=100\text{ns}$ ,  $t_r=0.2\text{ns}$ )



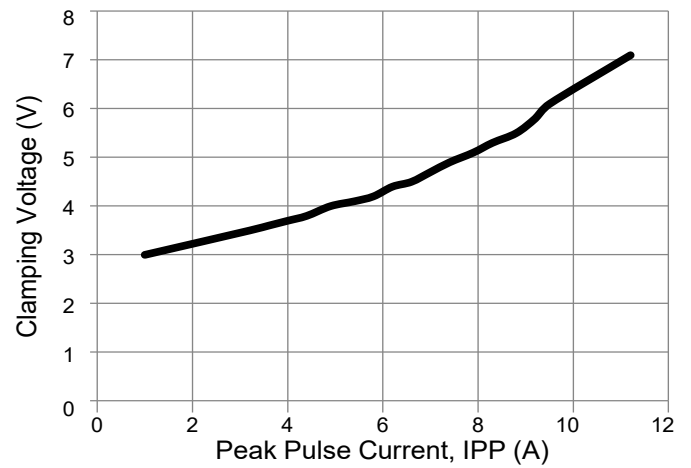
Negative Transmission Line Pulse

Typical Variations of CJ vs. Input Voltage

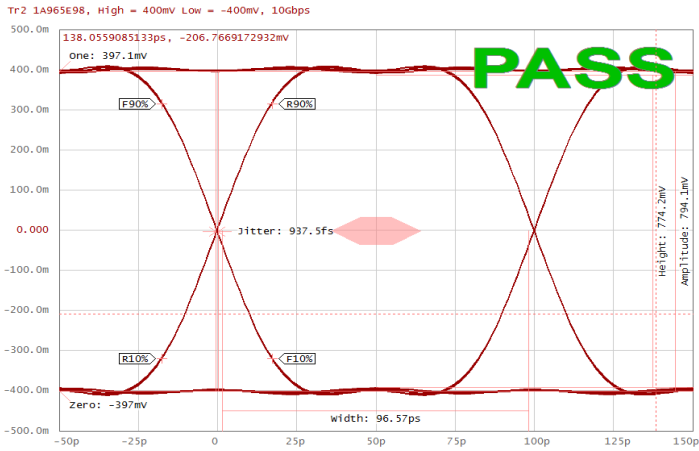


IEC61000-4-5 Surge 8/20 $\mu\text{s}$  (Any pin to pin)

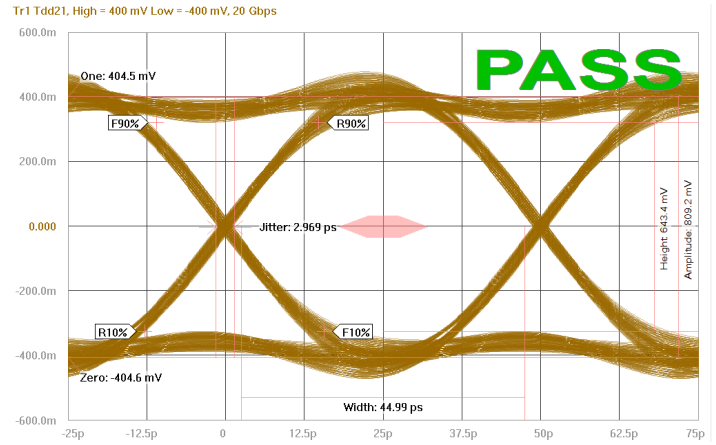

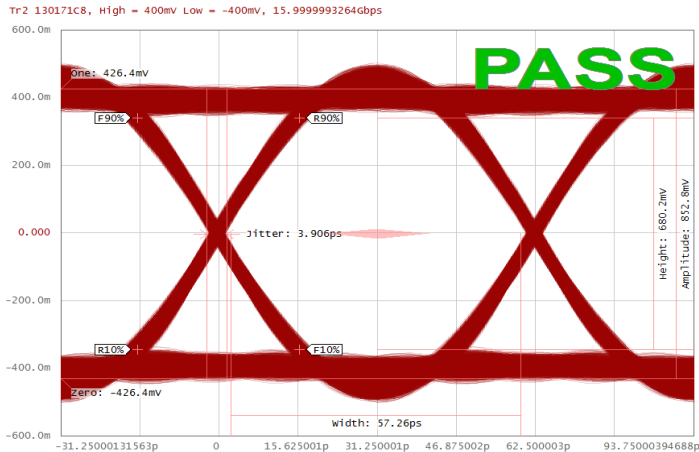
USB3.2 Gen2 Eye Diagram (10 Gbps)



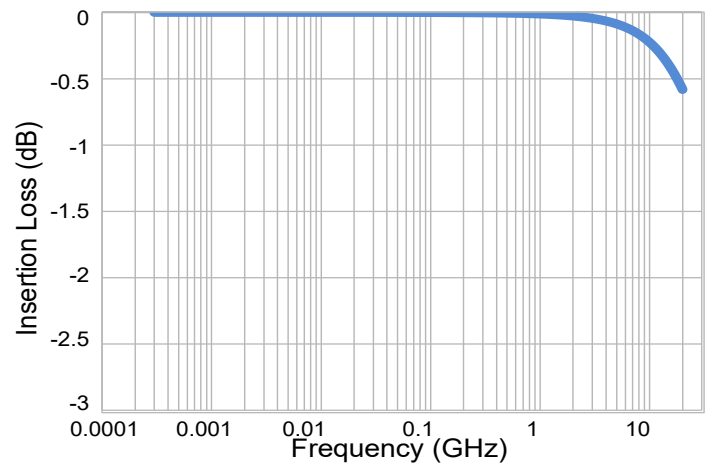
HDMI2.1 Eye Diagram (12 Gbps)
