

# AOZ8S501BS2-05

2-Channel Bidirectional High-Surge TVS

## **General Description**

The AOZ8S501BS2-05 is a 2-channel bidirectional high surge transient voltage suppressor designed to protect data lines such as audio line and power rail from damaging ESD or surge events.

This device incorporates two Bidirectional TVS diodes in a single package. During transient conditions, the bidirectional diodes direct the transient to either the positive side of the power supply line or to ground.

The AOZ8S501BS2-05 provides a typical capacitance of 35 pF and low clamping voltage making it ideally suited for data transmission protection in mobile and computing devices.

The AOZ8S501BS2-05 comes in a RoHS compliant and Halogen Free SOT23-3L package and is rated for -40°C to +125°C junction temperature range.






## **Typical Application**




# **Typical Characteristics**
